Required Findings Determination of Similar Use

The Community Development Department must make the following findings in order to approve a request for Determination of Similar Uses. These findings are required per Section 17.73.030(E) of the Wasco Municipal Code.

REQUIRED FINDINGS

Section 17.73.030(E) Basis for Determination of Similar Use

The determination of similar use shall constitute a ministerial action. In making a determination of similar use, the planning director, or planning commission, acting on an appeal shall determine that a proposed or contemplated use is similar to a use or uses expressly authorized in the applicable zoning district or districts if the proposed or contemplated use meets the following criteria:

1. The use resembles or is of the same basic nature as a use or uses expressly authorized in the applicable zoning district or districts in terms of the following:
 - a. The activities involved in or equipment or materials employed in the use;
 - b. The effects of the use on the surrounding area, such as traffic impacts, noise, dust, odors, vibrations, and appearance.
2. The use is consistent with the stated purpose of the applicable district or districts.
