• Entering a contract with a company that deals with blighted and foreclosed properties. This company helps with the rehabilitation of homes and takes them into the real estate marketing.

• The second item was to contract a company to market the City and bring in retail business to the City.

Juan Torres expressed his disapproval of the two additional recommended items.

There was a discussion between Committee and staff, regarding the cost of City-owned Police Station, in conclusion, the additional items suggested were not approved for recommendation to the City Council. The Committee agreed to add an item to the proposed list. Their recommendation is a Request for Proposal (RFP) to contract a company to do a police services analysis report.
